It is expressly understood that alcoholic beverages may be furnished and used, but not sold, only by named permit holder and invited guests, 21 years of age or older, and only within the designated premises during the hours specified. This special permit is issued subject to all applicable ordinances, rules and regulations of the Park District and all laws, regulations or other requirements of any other governmental authority having jurisdiction over the premises. The signing permittee, his or her organization, all officers and members thereof and all guests, invitees and persons claiming through the permittee assume full and sole responsibility therefor. Permittee shall be responsible to leave the premises in a clean condition after use. No activity in or use of the property under this special permit is sponsored or supervised by the Deerfield Park District. Permittee shall be responsible for examining the condition of the premises prior to use. This permit is expressly made subject to the terms aforesaid and on the back hereof and signer acknowledges that he/ she has read all of the same and in consideration of issuance of the permit agrees individually and on behalf of any organization named and its officers and members, guests, and invitees, to abide by same. Additional Conditions of Special Permit

1. This Special Permit [but not the permittee's obligations hereunder] expires at the closing hour on the date specified on the reverse side hereof, and an hourly charge may be assessed for failure to vacate promptly. Any damage deposit will be returned within a reasonable period after expiration, after the premises have been inspected and found in the same condition as at commencement of this permit. If any damage is incurred, all repair/replacements costs will be deducted from the damage deposit. Should the deposit prove insufficient to cover damage, permittee shall be obligated to make good the deficiency by further remittance to the Deerfield Park District.
2. No alcoholic beverage shall be served or furnished to any minor or person under the influence thereof at any function covered by this permit. Permittee's guests and invitees shall not exceed the number listed on the reverse hereof, and shall remain with the area designated in this permit, especially while alcoholic beverages are in use.
3. Any disorderly behavior or conduct in breach of the peace shall be in violation of this Special Permit. Violation of this and any other term of this Special Permit shall be grounds for immediate termination of all use hereunder as well as any other appropriate law enforcement and civil remedies, including but not limited to retention of all monies deposited by permittee.
4. Neither the Deerfield Park district nor its agents or employees shall be liable for damages to the permittee or to any person claiming through permittee for injury to person or damage to or loss of property wherever located from any cause; this provision includes particularly but not exclusively all claims relating to consumption of alcohol arising from the condition of the premises, including but not limited to the building or structure, if any appurtenance, furnishing or fixture or part of said building or structure veing or becoming out of repair or from any equipment or apparatus located in the damaged premises wheresoever, or from any act or neglect of the Deerfield Park District, its agents or servants or any any user or occupant of such premises or of the neighboring property.
5. Permittee individually and for the named organizations, if any, its members, officers, guests and invitees, covenants and agrees that it/they shall at all times protect, indemnify and save and keep harmless the Deerfield Park District against and from any and all claims, costs, damage or expense arising out of or from any accident or other occurrence on or about the demised premises or arising from any activity under this permit, causing injury or damage to any person or property whomsoever or whatsoever.
